**Proclamation to Amend the Oromia Investment Administration Establishment Proclamation No. 2/1995**

- Short Title**  
 This Proclamation may be cited as the "Oromia Investment Administration Establishment Proclamation No. 2/1995 (Amendment) Proclamation No. 40/2001."
- Amendments**  
 Sub-Article (f) of Article 6 is amended to read as Sub-Article "(g)" and the following new Sub-Article (f) is added to Article 6:  
 (f) "other persons assigned by the committee..... member"
- Effective Date**  
 This Proclamation shall enter into force as of the 11<sup>th</sup> day of April 2001.
