WHEREAS, it is found necessary to

 NOW, THEREFORE, in accordance with  
 article 49(3)(a) of the Regional  
 Constitution, it is hereby proclaimed as  
 follows:

1. Mata Duree Gabaabaa  
 Labsiin kun "Labsii Qaraxa Tembeeraa Mootummaa Naannoo Oromiyaa Lakk. 77/1996 fooyyeesuuf Labsii Bahe Lakk. 89/1997" jedhamee waamamuu ni danda'a.
2. Fooyya'iinsa  
 Labsii Qaraxa Tembeeraa Mootummaa Naannoo Oromiyaa lakk. 77/1996, keewwata 6 keewwata xiqqaa 3<sup>ffaa</sup> tti aanee keewwatni xiqqaa 4<sup>ffaa</sup> haarawaan akka itti aanutti dabalameera:
4. Barbaachisaa ta'ee yoo arge namootni tajaajilamtootaaf akka gurguran tembeera hir'ifama gatiitiin itti gurguruu ni danda'a. Hammii hir'ifama gatii fi haalli raawwii isaa qajeelfamaan murtaa'a.

1. Short Title  
 This Proclamation may be cited as "The Oromia Regional Government Stamp duty amendment Proclamation No. 89/2005"
2. Amendment  
 The Oromia Regional Government Stamp Duty Proclamation No. 77/2004 after Article 6 Sub Article 3, new sub article 4 is added as follows:
4. If it deems necessary, the Bureau may sell in discount price to the persons who sell to the users. The amount of discount and its implementation shall be decided by directives.
3. Effective Date  
 This Proclamation shall enter into force as of 2<sup>nd</sup> March 2005.
